

DISH “MARCH 2026 PLAY SCAPES” SWEEPSTAKES

OFFICIAL RULES

Please read the Official Rules and Regulations (“Official Rules”) of the “DISH ‘MARCH 2026 PLAY scapes’ Sweepstakes” (“Sweepstakes”). You must agree to accept and comply with the Official Rules to participate in the Sweepstakes. Dates: This Sweepstakes is valid from 3/1/26, 3:00 AM MT, through 3/31/26, 11:59 PM MT (“Sweepstakes Period”).

Eligibility: This Sweepstakes is open to legal residents of the forty-eight contiguous United States United States and D.C. (excluding, without limitation, residents of the States of Alaska and Hawaii, Puerto Rico, the U.S. Virgin Islands and other U.S. territories) who are 18 years of age (or age of majority in his or her state) and older at the time of entry and existing DISH customers as of February 28, 2026 at 11:59 PM MT. Employees, directors, officers and their immediate families (spouse, parents, children, siblings, and each of their spouses regardless where they live) or members of households of DISH Network L.L.C. (“Sponsor) or Versant Media, LLC (“Prize Provider”), and each of their respective parent companies, subsidiaries, advertising, design, print production and publicity agencies and anyone connected with the production and distribution of this sweepstakes, are not eligible to enter or be awarded a prize.

Potential Winners will be notified by email at Sponsor's discretion on or about 4/8/26. If a Potential Winner does not accept a prize, or is found to be ineligible or not in compliance with these Official Rules such prize may be forfeited and may be awarded to an alternate Winner, time permitting.
